You must meet the following conditions in order to be eligible for an Indian tourist and business e-Visa:

- 1) You must have an "ordinary" tourist passport (as opposed to a diplomatic/official/military passport) which is valid for at least six months past date of exit of India.
- 2) Your sole objective is **Business visit** for various business purposes; or **Medical** procedures.
 - ☐ Attend Technical/business Meetings
 - ☐ To Set up Industrial/business Venture ☐ Conducting Tours
 - ☐ Sale/purchase/trade ☐ To Recruit Manpower
 - ☐ Participation in Exhibitions, Business/trade Fairs
 - ☐ Expert/specialist in Connection with an Ongoing Project
 - ☐ Deliver Lecture/s under Global Initiative for Academic Networks (GIAN)
- You will be travelling on a round trip ticket with a stay of less than 60 days in India. The validity of e-Visa will be 60 days from the date of arrival in India. Double entry is permitted on e-Tourist Visa and e-Business Visa. Triple entry will be permitted on e-Medical Visa.
- 4) You wish to obtain a short term, double-entry visa (not a long term multiple entry visa).
- You must arrive in India by scheduled airline flight at one of the following airports: Ahmedabad, Amritsar, Bagdogra, Bengaluru, Calicut, Chennai, Chandigarh, Cochin, Coimbatore, Delhi, Gaya, Goa, Guwahati, Hyderabad, Jaipur, Kolkata, Lucknow, Mangalore, Mumbai, Nagpur, Pune, Tiruchirapalli, Trivandrum & Varanasi. You may arrive by regular tourist cruise ship at any of the following seaports: Cochin, Goa, Mangalore, Mumbai, Chennai. You may exit from any of the authorized Immigration Check Posts (ICPs) in India.
 - Tou may exit from any of the authorized infinigration check rosts (ICFs) in India.
- 6) You or your parents or your grandparents were/are not Pakistani citizens (meaning the applicant is not of Pakistani heritage going back two generations). Pakistani-Canadians seeking Indian visas must apply through the Indian High Commission.
- 7) Your date of arrival in India must **not be greater than 120 days from today**.
- 8) Your date of arrival in India must be greater than 5 days from today.
- 9) e-Visa is not allowed for employment, NGO / volunteer activities, journalism or conference purposes. You will need a full paper visa for these purposes.


