The Indian forms are very difficult for many people, tourist especially, to fill in at the on-line Indian government website. We offer an Indian form filling service to those who cannot do this themselves. In order for Visa Services Canada, Inc., to fill in the on-line Indian visa form on your behalf, you must do the following:

- provide a PDF scan of your *signed* passport, valid for at least 7 months after return from India
- provide a PDF scan of your previous non-Canadian *signed* passport for persons not born in Canada
- provide a PDF scan of your fully completed and signed on-line visa application form (below)
- provide a PDF scan of your utility bill and/or driving license to be used to support your application. The address on this document must be the one you use on your application so the address on the form below must look exactly like the address on your document.
- provide a high-quality colour JPEG image of your standard 51mm x 51mm colour passport photograph, showing full face on white background. Face must be at least 30mm in length. Shoulders must reach and bleed over the edge of the image. There cannot be white space on either side of the body.
 - Maximum JPEG photo file size is 1 Mb.
 - JPEG images must be exactly 350 x 350 pixels.
- All questions below and answers are MANDATORY. You must answer each and every question. There are no blanks. Provide complete and detailed answers as these are required by the Indian government.
- Clients must provide a real valid usable telephone and mobile number so we can contact you during the filling of the form. This is in case there are errors or omissions in your forms.
- EMAIL all documents and the photograph to our office for processing.

- We will email the finalized Indian visa PDF to you for signing and shipping.
