VISIT VISA (for persons invited to Nigeria by family, friends, and other non-business persons)

You must put these items in the application package:

- **original signed passport**, valid for at least 6 months after return to Canada,
- one (1) fully completed **typed** and **signed** Nigerian visa application form,
- one (1) recent 40mm x 40mm colour ID photograph against white background,
- a return air ticket or a letter from your travel agent,

- signed letter or document of invitation, which must also explain how the invitor met the invitee, and must state they will *not* hold responsible for anything the Nigerian High Commission in Ottawa.
- signed letter from the applicant requesting the visa, explaining how the invitee met the invitor, and must state they will *not* hold responsible for anything the Nigerian High Commission in Ottawa.
- high-quality copy of the Nigerian national ID card or Nigerian passport of the invitor,

- letter from employer confirming employment in Canada,
- evidence of sufficient funds to cover the cost of the trip --- copy of bank receipts for purchase of US\$ covering at least US\$100 per day in Nigeria (a 7-day visit to Nigeria means needing US\$700.),

- copy of Yellow Fever certificate,
- applications for minors must be accompanied by letters of consent endorsed by a Notary and signed by both parents and include copies of both parental passports; and the registration of birth which bears the name of either or both parents, endorsed by a Notary.
- Nigerians holding Canadian passports must provide copies of their Nigerian passport,
- former Nigerian nationals must have an invitation letter.
- non-Canadian passport holders must submit a copy of their Permanent Residence card.

- Applicant who are church or mission visitors requires Immigration Approval from the NIS (Nigerian Immigration Services) in Abuja. Applicant engaged in religious or evangelical activities requires Temporary Work Permit (TWP) approval from the federal government in Abuja.

TOURIST VISA (meaning actual tourists staying in real hotels)

You must put these items in the application package:

- **original signed passport**, valid for at least 6 months after return to Canada,
- one (1) fully completed **typed** and **signed** Nigerian visa application form,
- one (1) recent 40mm x 40mm colour ID photograph against white background,
- a return air ticket showing entry and exit of Nigeria, or a letter from your travel agent,

- proof of confirmed hotel for the entire duration of the ticketed time in Nigeria,
- copy of the hotel ID card of the manager and the manager's Nigerian national ID card,

- signed letter from the applicant requesting the visa, explaining their tourist journey to Nigeria. It must say that they will *not* hold responsible for any problems the Nigerian High Commission.

- letter from employer confirming employment in Canada,

- evidence of sufficient funds to cover the cost of the trip --- copy of bank receipts for purchase of US\$ covering at least US\$100 per day in Nigeria (a 7-day visit to Nigeria means needing US\$700.),

- copy of Yellow Fever certificate,

- applications for minors must be accompanied by letters of consent endorsed by a Notary and signed by both parents and include copies of both parental passports; and the registration of birth which bears the name of either or both parents, embossed and signed by a Notary.

- Nigerians holding Canadian passports must provide copies of their Nigerian passport,
- non-Canadian passport holders must submit a copy of their Permanent Residence card.
- dual nationals must use their Canadian passport when applying in Canada.

- Applicant who are **church or mission visitors** requires Immigration Approval from the NIS (Nigerian Immigration Services) in Abuja. Applicant engaged in religious or evangelical activities requires Temporary Work Permit (TWP) approval from the federal government in Abuja.

SECURE PAYMENT FOR TOURIST & VISIT VISAS

Visa Services Canada, Inc. is pleased to offer the most secure means of payment available in Canada for the processing of your tourist or your visit visa. This is the mandatory payment form. As of January 2017 tourist/visit clients must pay by e-transfer. Credit card is no longer accepted.

INTERAC e-Transfer®

Interac e-Transfer is a funds transfer service between personal and business accounts at Canadian banks and other financial institutions. You do not have to provide any account details or even a credit card number to our company. Our staff never see any of your account details when you use an e-transfer method of payment. You deal only with your bank or financial institutions to make payment in a totally secure environment right from your home or office.



HOW IT WORKS

1. Fill in the entire visa application form, including the VSC cover page above, and send it to our office by courier or e-mail as applicable.
2. Our professional staff review your application and determine the total payment (including taxes and shipping) to be made by you.
3. **Our staff send you an e-mail detailing the full and final charges. This email will contain all the instructions for making the e-transfer. It will include the e-mail and security codes, and step-by-step instructions for you.**
4. You, or a friend or relative acting on your behalf, make the e-transfer to VSC for all the visa processing charges and fees.
5. It takes about 30 minutes for the bank to send the e-transfer notification to our office. We then receive the funds and can then pay the embassy on your behalf. Payment must be received before the embassy can be approached with your application.

Applicants **MUST** provide at least one (1) working and monitored e-mail address on the VSC cover page so that our staff can contact you with details of the payment. Please provide two.

An application form without a typed correct and monitored e-mail address cannot be processed.

Applicants who respond immediately are assisted first. Applicants who do not respond within three days (72 hours) will have their applications cancelled and their passports prepared for return. Failure to respond promptly may result in you missing your journey.
