TOURIST VISA APPLICATION FEES FOR VIET NAM

*** Visa fees and times are subject to change by embassies without notice (as of 01 March 2018) ***

TOURIST VISA FEES

Single Entry Visa (valid up to 1 month)

- Regular visa US\$60 Viet Nam fees are in US\$, but are charged in Cdn\$
- Urgent visa US\$80

Multiple Entry Visa (valid up to 1 month)

- Regular visa: US\$105 Viet Nam fees are in US\$, but are charged in Cdn\$
- Urgent visa: US\$125

Single Entry Visa (valid up to 3 months)

- Regular visa: US\$85 Viet Nam fees are in US\$, but are charged in Cdn\$
- Urgent visa: US\$105

Multiple Entry Visa (valid up to 3 months)

- Regular visa: US\$130 Viet Nam fees are in US\$, but are charged in Cdn\$
- Urgent visa: US\$150

- **URGENT SERVICE FEE** - ONE working day (per person per visa) \$150.
- **REGULAR SERVICE FEE** - FIVE working days (per person per visa) \$75.

SPECIFIC TOURIST VISA REQUIREMENTS FOR VIET NAM

TOURIST VISA You must put these items in the application package:

- ✓ - **original signed passport**, valid for at least 6 months after return to Canada,
- ✓ - plus one photocopy of the passport data page,
- ✓ - one (1) fully completed **ON-LINE**, printed, and signed visa application form, filled in at the following website: <http://visa.mofa.gov.vn>
- ✓ - one (1) recent passport-style photograph.

Once you have typed and printed out and signed all the forms, ship everything, including your passport and photos, by trackable courier (Purolator or FedEx) or Canada Post trackable courier, to:

ON-LINE VISA FORM FOR VIET NAM VISA

Go to the website listed above (click on it or copy it to your browser) to fill in your on-line Viet Nam visa application form.

Select ENGLISH to continue.

If you are a Tourist: select TOURIST as the purpose of entry.

If you are on a business trip: select BUSINESS TRAVEL and then type the name of the commercial entity you are visiting as your purpose of entry.

Select EMBASSY of VIET NAM in CANADA as the place of submission and pick-up.

You do not have to upload a photograph. You can send a regular passport-style photo with your application package. Photo uploads are encouraged if possible.

Please type the full name and address of your employer or school for Workplace and Current Address. This means street, city, province and postal code.

You *must* enter your real correct email address under Email in order to receive your Application ID and your Code Confirmation from the Viet Nam government.

Select ORDINARY for your passport type. Canadians use ORDINARY passports.

Type the real address of the hotel in the box marker Proposed address in Viet Nam.

TOURISTS do not need a sponsor. Please do not list any sponsor.

BUSINESS has an official company or organization sponsor to fill in under Sponsor Information.

At the end select type in the security code and submit the data. Your form will pop up on the screen, fully filled.

Hit DOWNLOAD to get a copy for yourself (save it to your computer), and PRINT a copy.

Remember to SIGN your form. All forms must be signed by the applicant.

EMBASSY REGISTRATION

For your personal safety and security we can register you with the embassy of Canada in the country or countries to which you will travel on your upcoming business or tourist journey.

During times of national emergency such as natural disasters, war, or bombings, the government of Canada may seek out all Canadian nationals in a disaster or security zone. Canadians who are registered are the first ones found and can be the first evacuated in some cases.

This is a fast and efficient way of ensuring the Canadian Government can find you in case of an emergency, and can give your family some security during your travels.

ON-LINE VISA AUTHORIZATION FOR VIET NAM

ULTRA-FAST CONCIERGE VIP VISA AND AIRPORT VIP IMMIGRATION SERVICE

We and the embassy of Viet Nam are pleased to offer a new VIP Viet Nam Visa Service which includes the visa authorization letter, the airport visa fee, a person to meet you and to escort you through the VIP immigration line, all for one good price.

This service can only be used within one week of your entry date of Viet Nam.

- 1 month Single -includes Fee for Approval document from Embassy of Vietnam + Visa stamp fee + fast check-in VIP Gate - US\$129. + US\$50. = US\$179.

Viet Nam fees are in US\$, but are charged in Cdn\$

- 1 month Multiple - includes Fee for Approval document from Embassy of Vietnam + Visa stamp fee + fast check-in VIP Gate - US\$169. + US\$50. = US\$219.

Viet Nam fees are in US\$, but are charged in Cdn\$

- 3 months Single - includes Fee for Approval document from Embassy of Vietnam + Visa stamp fee + fast check-in VIP Gate - US\$169. + US\$50. = US\$219

Viet Nam fees are in US\$, but are charged in Cdn\$

- 3 months Multiple - includes Fee for Approval document from Embassy of Vietnam + Visa stamp fee + fast check-in VIP Gate - US\$229. + US\$50. = US\$279.

SECURE PAYMENT FOR TOURIST & VISIT VISAS

Visa Services Canada, Inc. is pleased to offer the most secure means of payment available in Canada for the processing of your tourist or your visit visa. This is the mandatory payment form. As of January 2017 tourist/visit clients must pay by e-transfer. Credit card is no longer accepted.

INTERAC e-Transfer®

Interac e-Transfer is a funds transfer service between personal and business accounts at Canadian banks and other financial institutions. You do not have to provide any account details or even a credit card number to our company. Our staff never see any of your account details when you use an e-transfer method of payment. You deal only with your bank or financial institutions to make payment in a totally secure environment right from your home or office.



HOW IT WORKS

1. Fill in the entire visa application form, including the VSC cover page above, and send it to our office by courier or e-mail as applicable.
2. Our professional staff review your application and determine the total payment (including taxes and shipping) to be made by you.
3. **Our staff send you an e-mail detailing the full and final charges. This email will contain all the instructions for making the e-transfer. It will include the e-mail and security codes, and step-by-step instructions for you.**
4. You, or a friend or relative acting on your behalf, make the e-transfer to VSC for all the visa processing charges and fees.
5. It takes about 30 minutes for the bank to send the e-transfer notification to our office. We then receive the funds and can then pay the embassy on your behalf. Payment must be received before the embassy can be approached with your application.

YOUR E-MAIL ADDRESS

Applicants **MUST** provide at least one (1) working and monitored e-mail address on the VSC cover page so that our staff can contact you with details of the payment. Please provide two.

An application form without a typed correct and monitored e-mail address cannot be processed.

Applicants who respond immediately are assisted first. Applicants who do not respond within three days (72 hours) will have their applications cancelled and their passports prepared for return. Failure to respond promptly may result in you missing your journey.
